TERMINATION OF REGISTRATION

Euronet Worldwide, Inc. (the Company) previously issued 6,374,528 shares of Common Stock (Shares) of the Company in a private placement and registered the Shares for resale in a Registration Statement on Form S-3 (File No. 333-141319) filed with the Commission on March 15, 2007 (together with all previously filed amendments and prospectus supplements, the Registration Statement).

In accordance with the undertaking contained in the Registration Statement pursuant to Item 512(a)(3) of Regulation S-K, we are filing this Post-Effective Amendment to remove from registration all of the Shares that remain unsold under the Registration Statement as of the date hereof. We are deregistering these Shares because our obligation to maintain the effectiveness of the Registration Statement pursuant to the Securities Purchase Agreement dated as of March 8, 2007 among the Company and the initial purchasers of the Shares, has expired.
