Item 4.

#### Purpose of Transaction

The Reporting Persons acquired the Shares for investment purposes. Any such acquisitions or dispositions may be made, subject to applicable law, in open market transactions, privately negotiated transactions or, in the case of dispositions, pursuant to a registration statement. The Reporting Persons may act independently in evaluating and effecting any such transactions.
