IntelGenx Technologies Corp. As of the Record Date, there were 63,615,256 shares outstanding of the Company s common stock at \$0.00001 par value (the IntelGenx Common Stock). At the 2016 Annual Meeting, Record Date shareholders holding 46,411,547 shares (72,957%) of the IntelGenx Common Stock were present in person or per proxy. Each such shareholder was entitled to one vote for each share of the IntelGenx Common Stock held on the Record Day.

- (ii) the ratification of Richter LLP as the Company s independent auditors for the fiscal year ending December 31, 2016.
