#### ITEM 1.01 ENTRY INTO A MATERIAL DEFINITIVE AGREEMENT

On June 20, 2007, we were awarded a delivery order by the U.S. Marine Corps, under our letter contract dated January 25, 2007, filed as an exhibit to our Form 8-K dated February 5, 2007, for 455 Mine Resistant Ambush Protected (MRAP) vehicles, for a total consideration of approximately \$221 million. This order calls for 395 Category I Cougar 4X4 and 60 Category II 6X6 vehicles, which will be used by different branches of the United States military.
