**MTS announces subscriber growth numbers for July 2008**

**Moscow, Russian Federation Mobile TeleSystems OJSC ( MTS NYSE: MBT), the largest mobile phone operator in Russia and the CIS, announces that its consolidated subscriber base reached 87.26 million users on July 31, 2008.**

During July 2008, MTS consolidated subscriber base increased by 0.32 million subscribers with 0.48 million added in Russia.
