EXPLANATORY NOTE

This Amendment No. 5 to Schedule 13D (Amendment No. 5) relates to the common shares of beneficial interest, no par value (Common Shares) of Western Asset/Claymore Inflation-Linked Opportunities & Income Fund (the Issuer). This Amendment No. 5 is filed to amend and supplement the Items set forth below of the Reporting Persons Schedule 13D previously filed with the Securities and Exchange Commission on January 9, 2006, as amended on May 3, 2006, September 29, 2008, April 22, 2009 and May 1, 2009.

Item 3. Source and Amount of Funds or Other Consideration

During the past sixty days, Cascade purchased 28,009 Common Shares of the Issuer with its working capital for an aggregate purchase price of \$351,405.20. Cascade also acquired 35,320 Common Shares pursuant to a dividend reinvestment plan of the Issuer. Other than the reinvestment of such dividend, Cascade paid no consideration to acquire these shares.
