**ITEM 8.01. OTHER EVENTS.**

On June 22, 2015, in accordance with the terms of the Agreement and Plan of Merger, dated as of June 22, 2014, among Integrys Energy Group, Inc. ( Integrys ), Wisconsin Energy Corporation ( Wisconsin Energy ), WEC Acquisition Corp. and GET Acquisition Corp. (n/k/a Integrys Holding, Inc.) (the Merger Agreement ), each of Wisconsin Energy and Integrys delivered written notice to the other that such party had elected to extend the End Date (as defined in the Merger Agreement) beyond its initial one year term to allow for the receipt of all required governmental approvals.

The foregoing description of the Merger Agreement is subject to, and is qualified in its entirety by, the full text of the Merger Agreement, which is filed as Exhibit 2.1 to the Current Report filed by Wisconsin Energy Corporation on June 23, 2014, and which is incorporated herein by reference.
