On September 21, 2011, the Company entered into a variable rate term loan agreement for 12.55 billion Japanese yen (the "Yen Agreement"), of which the proceeds will be received by the Company by the end of September 2011, and which matures on September 29, 2014. The proceeds of the Yen Agreement will be used to prepay an existing yen denominated variable rate term loan for the same principle amount, which was set to mature in March 2012. The Yen Agreement is filed as Exhibit 4.9 to this Current Report on Form 8-K and is incorporated herein by reference.
