(1) As more particularly described in the Form 4 filed by the other reporting person with the United States Securities and Exchange Commission on March 2, 2012, the reporting person exercised in full their basic subscription rights in the rights offering entitling them to purchase shares of Pilgrim's Pride Corporation ("PPC") common stock. The reporting persons acquired 528 shares of common stock, as determined by the transfer agent on March 12, 2012, when issued by PPC at the closing.
