On September 11, 2003, MGM MIRAGE, a Delaware corporation (the Company ), entered into an Underwriting Agreement (the Underwriting Agreement ), between the Company and certain of its subsidiaries (the Subsidiary Guarantors ), on the one hand, and Banc of America Securities LLC (the Manager ) and Citigroup Global Markets Inc., Deutsche Bank Securities Inc. and J.P. Morgan Securities Inc. (the Joint Book-runners ) and each of the Underwriters named therein, for whom the Manager and the Joint Book-runners are acting as representatives, on the other hand, regarding the sale by the Company and the purchase by such Underwriters of \$600,000,000 aggregate principal amount of the Company s 6% Senior Notes Due 2009 (the Notes ). The Underwriting Agreement is filed as Exhibit 1 to this Current Report and is incorporated herein by reference. On September 17, 2003, the Company entered into an Indenture (the Indenture ), by and among the Company, as issuer, the Subsidiary Guarantors, as guarantors, and U.S. Bank National Association, as Trustee, in connection with the issuance of the Notes. The Indenture is filed as Exhibit 4.1 to this Current Report and is incorporated herein by reference. The form of Global Note referenced in the Indenture is filed as Exhibit 4.2 to this Current Report and is incorporated herein by reference.
