EXPLANATORY NOTE

On October 14, 2005, we filed a Form 8-K regarding our results of operations for the quarter ended September 30, 2005. This Form 8-K/A corrects depreciation and amortization reported for our Shopzilla business segment in Note 3, Segment Information. The correction increases Shopzilla's reported amortization by \$2.4 million and decreases their reported depreciation by the same amount.

**Item 2.02. Results of Operations and Financial Condition**

On October 14, 2005, we released information regarding results of operations for the quarter ended September 30, 2005. A copy of the press release is filed as Exhibit 99.
