#### Item 1.01 Entry into a Material Definitive Agreement.

On April 15, 2016, StoneMor Partners L.P. (the Partnership ), StoneMor GP LLC, the general partner of the Partnership, and StoneMor Operating LLC, a wholly owned subsidiary of the Partnership, entered into an Underwriting Agreement (the Underwriting Agreement ) with Raymond James & Associates, Inc., as representative of the underwriters named in the Underwriting Agreement (the Underwriters ).

The Underwriting Agreement provides for the issuance and sale by the Partnership of 2,000,000 common units representing limited partner interests in the Partnership (Common Units) in an underwritten public offering (the Units Offering) at a price to the public of \$23.65 per Common Unit. The Partnership has also granted the Underwriters a 30-day option to purchase up to 300,000 additional Common Units to cover over-allotments.

Raymond James & Associates, Inc. is an affiliate of one of the lenders under the Partnership s Fourth Amended and Restated Credit Agreement, dated as of December 19, 2014, as amended, which will receive a portion of the proceeds of the Units Offering.

The Partnership s sale of the Common Units in the Units Offering was registered under the Securities Act of 1933, as amended, pursuant to the Partnership s shelf registration statement on Form S-3 (File No. 333-210264).

The Partnership expects that the Units Offering will close on April 20, 2016, subject to customary closing conditions. The foregoing description of the Underwriting Agreement does not purport to be complete and is qualified in its entirety by reference to the full text of the Underwriting Agreement, which is filed as Exhibit 1.1 to this Current Report on Form 8-K and is incorporated herein by reference.
