- (1) These shares were granted in the form of Deferred Stock Units ("DSUs"), in connection with the cash dividend paid on June 24, 2016 to stockholders of record as of June 10, 2016 (the "Dividend"), with respect to 3,267 vested DSUs granted to the reporting person on August 10, 2015, and adjusted for previously declared and paid cash dividends.
