The shares of Series A Preferred Stock automatically, without any action by the holders of the Series A Preferred Stock, converted into Common Stock as of the close of business on January 4, 2017 (the "<u>Automatic Conversion</u>").

Item 5. INTEREST IN SECURITIES OF THE ISSUER

(c) The Reporting Persons' response to Item 4 is incorporated by reference into this Item 5(c).
