Thank you for calling the Dollar Tree business update hotline. This is Adam Bergman, Director of Investor Relations.

The information on this call about our future expectations, plans and prospects constitute forward-looking statements under the Private Securities Litigation Reform Act of 1995. Our actual results may differ materially from those indicated by these forward-looking statements as a result of various important factors, including national and international events, consumer spending, and others described in our recent Annual Report and Quarterly Report on file with the SEC. This information is current only as of the date presented, and we will not update this information until our official quarterly sales release scheduled for Thursday, November 4th, before market open.

Our previous guidance for the fiscal third quarter, which runs from August 1st through October 30st, is for total sales to be in the range of 730 to 750 million dollars, which is based on flat to slightly positive comparable store sales. Through October 4th, comp-store sales results are running in-line with our expectation, while new-store volume is slightly below expectation. As a result, total sales are running toward the lower end of our sales range.

As of October 4th, 2004, we operated 2,646 stores in 48 states, compared to 2,491 stores in 47 states a year ago.
