### Item 9. Regulation FD Disclosure.

On December 5, 2001, the Registrant commenced a self tender offer to purchase up to 13,500,000 of its outstanding Class A Transferable Warrants (Nasdaq: ENDPW) and any and all of its outstanding Class B Non-Transferable Warrants. The Registrant is offering to purchase the Warrants at a purchase price of \$0.75 per Warrant. The offer is scheduled to expire at 12:00 midnight, New York City time, on January 14, 2002, unless the Company elects to extend the offer. The offer is subject to various conditions described in the Offer to Purchase.
