(a) Amount Beneficially Owned:

As of the date of this filing, each Reporting Person may be deemed to be the beneficial owner of 474,000 shares of Common Stock owned by Millenco, L.L.C., a Delaware limited liability company ("Millenco"), formerly known as Millenco, L.P., a Delaware limited partnership.

In addition, Millenco owns warrants ("Warrants") exercisable into 1,139,810 shares of Common Stock. Each Warrant entitles the holder to purchase one share of the Company's Common Stock at a price of \$5.00 and will expire on June 23, 2008, or earlier upon redemption.

Millenco has an open short position of 686,563 shares of Common Stock, which position is not netted against the data provided herein for the purpose of determining the number of shares beneficially owned by the Reporting Persons.

Millennium Management, L.L.C., a Delaware limited liability company ("Millennium Management"), is the manager of Millenco, and consequently may be deemed to have voting control and investment discretion over securities owned by Millenco. Israel A. Englander ("Mr. Englander") is the managing member of Millennium Management. As a result, Mr. Englander may be deemed to be the beneficial owner of any shares deemed to be beneficially owned by Millennium Management. The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the shares owned by Millenco.

Note: Integrated Holding Group, L.P., a Delaware limited partnership ("Integrated Holding Group"), is a non-managing member of Millenco. As a non-managing member, Integrated Holding Group has no investment or voting control over Millenco or its securities positions.

6.9% of the Company's Common Stock (see Item 4(a) above), which percentage was calculated based on 22,300,148 shares of Common Stock outstanding as of November 6, 2006, as reported in the Company's Quarterly Report on Form 10-Q, dated as of November 14, 2006.
