On August 4, 2006, Lennar Corporation (the "Company") revised its Code of Business Conduct and Ethics. The revisions take into account advances in corporate governance best practices and compliance-driven concepts, including (1) the integration of concepts that associates must deal "in the spirit" of the Code and in "good faith," (2) additional guidelines concerning compliance with specific regulatory regimes relating to the environment, employment matters, campaign finance and lobbying, Sarbanes-Oxley and insider trading and (3) additional guidelines concerning the Real Estate Settlement Procedures Act ("RESPA").
