- (2) Mr. Pini did not pay for the shares in question; they were awarded to him pursuant to the Issuer's non-employee director compensation policy. 12,500 shares were awarded for his service as a Board member; 6,250 were awarded for his service as Chairman of the Corporate Governance Committee; and 3,750 shares were awarded for his service on the Compensation Committee. The date of award was a federal holiday; on February 21, 2006, the next trading day, the closing price of the subject shares was \$0.41 per share.
