On May 10, 2007, at a regularly-scheduled meeting of the Board of Directors of Electronic Arts Inc. (the Company), M. Richard Asher, age 75, declared his intention to retire. Mr. Asher has served as a Director of the Company since 1984 and his retirement will become effective at the Company's 2007 Annual Meeting of Stockholders, which is scheduled for July 26, 2007.
