On July 10, 2008, ICOP Digital, Inc. (the Registrant) granted to each of Mr. Owen, the Registrant's Chief Executive Officer, and Ms. Owen, the Registrant's President, Chief Operating Officer and Corporate Secretary, 200,000 options to purchase shares of common stock at an exercise price of \$1.39 per share, the closing price of the Registrant's common stock on July 10, 2008, as reported on the NASDAQ Capital Market. These options are immediately exercisable, expire on July 10, 2018, and were granted pursuant to, and are subject to the terms, conditions and forfeiture provisions of, the Registrant's 2002 Stock Option Plan. The Registrant granted these options in exchange for (i) Mr. Owen's agreement to cancel 100,000 unvested shares of restricted stock, 50,000 options to purchase shares of common stock at \$5.85 per share and 50,000 options to purchase shares of common stock at \$6.80 per share, and (ii) Ms. Owen's agreement to cancel 100,000 unvested shares of restricted stock, 37,500 options to purchase shares of common stock at \$5.85 per share and 50,000 options to purchase shares of common stock at \$6.80.
