TERMINATION OF REGISTRATION

This Post-Effective Amendment No. 1 relates to the Registration Statement on Form S-8 (Registration No. 333-175472) (the *Registration Statement*) of MModal Inc. (formerly MedQuist Holdings Inc.) (the *Company*) filed with the Securities and Exchange Commission (the *Commission*) on July 11, 2011. The Registration Statement registered a total of 4,536,914 shares of the Company's common stock, par value \$0.10 per share (the *Securities*), to be offered or sold pursuant to the MedQuist Holdings Inc. 2010 Equity Incentive Plan, the MedQuist Holdings Inc. 2010 Employee Stock Purchase Plan and the Stand-Alone MedQuist Holdings Inc. Restricted Stock Award Agreement with Roger L. Davenport.

On August 17, 2012, pursuant to the terms of the Agreement and Plan of Merger, dated as of July 2, 2012, as amended, by and among the Company, Legend Parent, Inc. (*Parent*) and Legend Acquisition Sub, Inc., a wholly-owned subsidiary of Parent (*Merger Sub*), Merger Sub merged with and into the Company (the *Merger*), with the Company continuing as the surviving corporation and an indirectly wholly-owned subsidiary of Parent.

In connection with the Merger, the Registration Statement is hereby withdrawn and all Securities registered hereunder, which remain unsold as of the date hereof, are hereby removed from registration.
