- (1) The Series A Convertible Preferred Stock is convertible into Common Stock on a one-for-one basis at any time and has no expiration date. The Series A Convertible Preferred Stock and 62.5% of the accrued and unpaid dividends on such shares will automatically convert into Common Stock upon consummation of the Issuer's initial public offering.
- (2) Includes 162,705 shares that will be issued at the time of conversion of the Series A Convertible Preferred Stock in payment of 62.5% of the dividends on such shares accrued and unpaid as of that date, assuming an initial public offering closing date of August 17, 2010.
- (3) The Series C Convertible Preferred Stock is convertible into Common Stock on a one-for-one basis at any time and has no expiration date. The Series C Convertible Preferred Stock will automatically convert into Common Stock upon consummation of the Issuer's initial public offering.

### Remarks:

The anticipated effective date of Issuer's initial public offering is August 11, 2010. Jason A. Wright of directors pursuant to the reporting person's contractual right to designate a director and is expected his successor is appointed and qualified or until his earlier removal or resignation in accordance with of incorporation and bylaws. Jason A. Wright is a partner of an affiliate of the reporting person.
