- (1) The reporting person holds an option to buy 6,000 Common Shares (with tandem tax withholding rights) which was granted under the Invacare Corporation 2003 Performance Plan on August 19, 2009. The option becomes exercisable in four equal annual installments on September 30, 2010, 2011, 2012 and 2013 and will expire on August 19, 2019. The option was inadvertently not included on the reporting person's Form 3 due to a clerical error.
- (2) The reporting person holds options to buy a total of 50,300 (of which 44,300 were previously reported) Common Shares (with tandem tax withholding rights) under the Invacare Corporation 1994 Performance Plan and the Invacare Corporation 2003 Performance Plan, granted in reliance upon the exemption provided by Rule 16b-3. All options were granted between October 31, 2011 and August 18, 2010, at exercise prices between \$20.48 to \$43.90 per share, will expire between October 31, 2011 and August 18, 2020 and became or will become exercisable between September 30, 2002 and September 30, 2014.
