ITEM 2 TO THE SCHEDULE 13D/A FILED ON SEPTEMBER 11, 2007 IS HEREBY AMENDED AND

As a result of the transfer of certain management agreements and related transactions among Reporting Persons, certain of the Reporting Persons no longer have beneficial ownership of the shares, and two new Reporting Persons have been added, as follows:

("Harbinger Management"), the investment manager of HMC Atlas Air, HMC Investors, L.L.C. ("HMC Investors"), the former managing member of Harbinger Management, Harbinger Capital Partners Special Situations Fund, L.P. (the "Special Fund"), Harbinger

The principal business address for each of HMC Investors, HMC, Raymond J. Harbert and Michael D. Luce is 2100 Third Avenue North, Suite 600, Birmingham, Alabama 35203.
