Effective June 2, 2006, our Board of Directors appointed Roderick M. Sherwood, III as a director of Dot Hill Systems Corp. Mr. Sherwood was appointed to serve as a Class I director, continuing in office until our 2009 annual meeting of stockholders and until his successor is duly elected and qualified or until his earlier death, resignation or removal. Mr. Sherwood was also appointed as Chairman of our Audit Committee.

On June 2, 2006, under the terms of our 2005 Non-Employee Directors Plan, Mr. Sherwood received a grant of a non-qualified stock option to purchase 50,000 shares of Dot Hill s common stock. Mr. Sherwood is also entitled to receive customary director and retainer fees and an annual non-qualified stock option to purchase 20,000 shares of Dot Hill s common stock on each annual meeting of stockholders. Mr. Sherwood will also be entering into Dot Hill s standard form of indemnity agreement.
