As previously announced on May 14, 2004, HEALTHSOUTH Corporation (  $\frac{1}{2}$  HEALTHSOUTH ) consummated the consent solicitations relating to its 8.500% Senior Notes due 2008 and 10.750% Senior Subordinated Notes due 2008.

In connection with the consummation of the consent solicitations, on May 14, 2004, HEALTHSOUTH executed (i) the Second Supplemental Indenture, dated as of May 14, 2004 (the  $\,$  8.500% Supplemental Indenture  $\,$ ), to the Indenture, dated as of February 1, 2001, between HEALTHSOUTH and The Bank of New York, as trustee, governing its 8.500% Senior Notes due

2008 and (ii) the Second Supplemental Indenture, dated as of May 14, 2004 (the 10.750% Supplemental Indenture ), to the Indenture, dated as of September 25, 2000, between HEALTHSOUTH and HSBC Bank, as successor trustee to The Bank of New York, governing its 10.750% Senior Subordinated Notes due 2008.

A copy of the 8.500% Supplemental Indenture is attached hereto as Exhibit 99.1 and incorporated herein by reference. A copy of the 10.750% Supplemental Indenture is attached hereto as Exhibit 99.2 and incorporated herein by reference.
